## CORTAC PAYMENT INSTRUCTIONS

### 1. GENERAL INFORMATION

Thank you for participating in our CORTAC FTP program. This document describes the format for submitting payment files through the County's FTP website for processing. Annual Current Secured bills and Supplemental Secured bills can be submitted in this manner. The Tax Collector will accept only one electronic payment per payment file.

#### A. Current Secured Bills

Current Secured Bills are delinquent after December 10 (first installments) and April 10 (second installments). Please refer to the **Current Secured Detail Record format** for these bills.

#### B. Supplemental Secured Bills

Supplemental Secured Bills have varying due dates. Supplemental Secured Bills can be processed through the FTP interface only if the detail record meets all of the following criteria:

1. The bill number is the actual Supplemental bill number (not the original parcel number).
2. The installment number is 1 for first installment or 2 for second installment.
3. The detail record contains the Supplemental bill installment for these bills.
4. Please refer to the **Supplemental Secured Detail Record format** for these bills.

### 2. CORTAC FILE LAYOUT FOR FTP SUBMISSION

#### A. CORTAC File naming convention: <4 digit CORTAC ID>.TXT

Please use your CORTAC ID in the first characters of the name of the file you submit. Example: 9999.TXT.

#### B. CORTAC File layout

1. 60 Characters maximum record length.
2. Line endings marked with CR+LF pair (ODOA). This is a standard Text file format.
3. Fixed length fields separated by spaces or a delimiter such as a comma.
4. The file must begin with 1 header record, followed by any number of detail records and end with 1 trailer record.
5. For Current Secured first installment bills use "1" in the installment code field. Use the "Current Secured Detail Record format". Current Secured first Installment bills are delinquent December 10.
6. For Current Secured second installment bills use "2" in the installment code field. Use the "Current Secured Detail Record format". Current Secured second Installment bills are delinquent April 10.

7. For supplemental bills the bill number **MUST** be the Supplemental bill number—the first digit of the number must be “8” and the third digit must be “9” to be a Supplemental bill number. The delinquent date of the bill must be included. Use the “Supplemental Secured Record format”. For Supplemental first Installment bills, use “1” in the installment code field. For Supplemental second Installment bills, use “2” in the Installment code field. Supplemental Secured bills have varying delinquent dates.
8. If paying both installments, create one detail record for the first installment and another detail record for the second installment.
